## PUBLIC LIABILITY INSURANCE

In order to exhibit at Leisurefest, all exhibitors must have Public Liability Insurance. A CERTIFICATE OF CURRENCY must be submitted to the Organiser's office by 1 September 2010, with **Melbourne Racing Club and Melbourne Leisurefest endorsed as interested parties.**

- A Certificate of Currency is NOT A CERTIFICATE OF INSURANCE.
- A Certificate of Currency is NOT a copy of your Public Liability Policy.
- A Certificate of Currency is ONLY issued by an insurance company or a broker for a specific event.
